SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates, and phosphates. Store in a cool, dry place.

Avoid contact with eyes, skin, and clothing. Wear chemical splash goggles, chemical-resistant gloves, and chemical-resistant apron. Use ventilation to keep airborne concentrations below exposure limits. Always wear a NIOSH-approved respirator with proper cartridges or a positive pressure, air-supplied respirator when handling this material in emergency situations (spill or fire). Exposure guidelines: PEL 15 mg/m³ (as total dust) (OSHA)
