SECTION 2 — HAZARDS IDENTIFICATION

SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates and phosphates. Deliquescent. Store in a cool, dry place within a Flinn Chem-Saf™ bag. Keep container tightly closed (P233). Use only in a hood or well-ventilated area (P271).
